## Introduction

The need for development projects to remain on-course and the imperatives of generating measurable positive impact in the broader context of development underlines the importance of this program for development management professionals.

The size and the complexity of the project interventions, outputs, and outcomes, if, managed well for risk and deviations using Results Based Management Accountability framework, improves the likelihood of success of the project. This requires a participatory approach in planning, implementing, and collecting data on appropriate indicators to monitor the targets.

The competencies enhancement program also emphasizes evaluation communication to all the stakeholders of the projects for generating a better understanding of the status of the project through shared common knowledge. In the process of M&E the success stories get documented and problems are identified and recorded, either for effective redressal, or for avoidance of repetition.

## Learning Objectives

To enhance the managerial competencies of the participants by imparting them with knowledge of monitoring and evaluation frameworks to augment their skills in effective monitoring and evaluation of ongoing projects. The specific learning objectives are to:

- Build skills in developing qualitative and quantitative indicators
- Demonstrate application of knowledge on input and output monitoring
- Evaluating the project with the help of baseline data, indicators and other data sources
- Develop good analytical and reporting skills

- f. Planning the Operations for monitoring
- g. Capturing the baseline scenario
- h. Participatory Monitoring of indicators for achievement of output targets
- i. Data Analysis for Evaluation
- j. Reporting and Communication of Evaluation Findings

Project implementation staff and professionals in the development sector at middle and junior levels.
