1. Origin and Mission

Development Management Institute (DMI) was set up on 13 February, 2014, pursuant to a desire of the Government of Bihar to establish a High-Performance Knowledge Institution (HPKI). DMI believes that the livelihoods of small producers and marginalised people can be enhanced by organising them to form member participation based, democratically governed institutions that leverage the strengths of collectives and build enduring partnerships with professionals for reaping the benefits of technology and market integration. Inspired by and recognising the growing need for Development Management Professionals, the Government of Bihar took the initiative to establish DMI as an autonomous institution. The rationale of DMI is best captured in its mission:

"To empower and usher in participatory governance and management of institutions, enterprises and resources for enhancing livelihoods and generating sustainable development".

DMI endeavours to empower grassroots through:

- Creation of a cadre of Development Management professionals through its Post-graduate
 Diploma Programmes, Certificate Programmes and Courses, and the Fellow Programme;
- Enhancement of professional competencies of Development Management Professionals through short-duration Competencies Enhancement Programmes (CEPs);
- Engagement in networked trans-disciplinary Action Research, Policy Advocacy and Advisory Services through the following Collaborative Action Research and Education (CARE) centres:
 - Livelihoods and Well-being
 - Collectives and Commons
 - Leadership and Governance
- Orientation of Vision, Values and Leadership
 Practices towards Good Governance, by working with organisations, institutions and groups at different levels.

This report presents the efforts and achievements of DMI during the year 2020-21 towards the realisation of its mission.





2. Post-Graduate Programme in Development Management

The flagship programme of DMI is its two-year, full time, Post-Graduate Programme in Development Management (PDM) which aims at preparing its graduates to achieve:

- Personal growth through perspective building and interactive learning from foundational, functional and integrative courses, enriched by experiential learning and reflective dialoguing processes; and
- Transformation into Development Management Professionals through exposure to contextual realities during experiential learning spread over three phases - Development Immersion (DI), Enterprise Learning (EL) and Management Internship (MI), requiring course participants to stay and work at development sites on live projects.

The PDM curriculum is focused on imparting competencies necessary for the management of resources, enterprises, institutions and interventions, in an environment of participatory governance and stakeholder accountability, as shown in *Figure (i)*. The praxis-oriented interactive learning is facilitated by a faculty team of career academics, practising professionals and practitioner-turned academics endowed with domain expertise and experience.




Figure (i): PDM Programme Design



2.1 Progress of PDM (2020 - 21)

2.1.1 PDM 2018 - 20 (PDM 05)

All the final term examinations of Post Graduate Programme in Development Management (PDM05) were conducted in online mode. The course instructors adopted the open book examination method to avoid the risk of plagiarism during the examination. The final grades were evaluated and declared during May 2020. Forty-six participants were deemed to have met all the academic requirements for graduation from the programme.

The campus placements were held from 13 January to 16, 2020. The forty-six participants were placed in 14 organisations; they all have entered the professional world of development management. DMI continued to have a full placements record.

Organisations that recruited the PDM graduates ranged from Rural Producers' Co-operatives through Small Finance Banks and CSR Foundations to Non-government Development Organisations. The following is an illustrative list of recruiting organisations - Bihar Rural Livelihoods Promotion Society (BRLPS) - JEEViKA, Jal Jeevan Hariyali Mission, The Bihar State Milk Co-Operative Federation Ltd. (COMFED), Aga Khan Rural Support Programme (India), CARE India, Madhya Pradesh State Rural Livelihoods Mission (MPSRLM), Ministry of Education's (GoI) – MGNCRE, Bandhan Konnagar, SEWA Bharat, Technoserve, JM Financial Foundation, Ujjivan Small Finance Bank, Foundation for Rural Entrepreneurship Development (FREND).

The convocation ceremony for PDM 2018-20 could not be organised due to the COVID-19 Pandemic. The provisional certificates and transcripts have been issued consequent to the Board of Governors' approval of the Faculty Council's Resolution recommending the award of Post Graduate Diplomas to the successful candidates.





2.1.2 PDM 2019-21 (PDM 06)

The Pandemic related dislocations caused the revision of the academic calendar to be revised thrice. It was necessary to respond to the evolving situations of lockdown and related restrictions.

Enterprise Learning (EL): The duration of the eight-week-long Enterprise Learning module was reduced by 50% (4 weeks) and was facilitated online with the help of 11 host organisations. The online projects straddled the following subject areas: livelihoods, education, health, agriculture, dairying and local governance. After completing the Enterprise Learning Module, participants made presentations in virtual mode and submitted their reports to their respective Host Organisations and DMI. In *Table A* below, the list of host organisations and corresponding project titles are enumerated.

Management Internship (MI): The participants pursued their twelve-week long MI module with a different mix of organisations during the period 23 November 2020 to 12 February 2021. The MI has, at its core, project-based learning where the participants develop a realistic understanding of the managerial roles and responsibilities in sustainable development and management. The participants have undertaken the projects in the areas of livelihoods, education, health, horticulture, dairy, microfinance, women empowerment and waste management. 2.1.3 PDM 2020-22 (PDM 07)

The PDM 2020-22 commenced the academic session with a batch size of 53. Two dropped out for personal reasons. The current batch size is 51 paticipants, including one who rejoined from the just previous batch. The entire selection process was conducted online and included scores of AICTE - approved Management Admission Tests, viz. CAT, XAT, GMAT, MAT and CMAT, assessment of Writing Skills and Personal Interview.

The educational background and gender ratio of the participants are presented in *Figures (ii) and (iii)*.




Figure (ii): Undergraduate Profile of PDM 2020-22




Figure (iii): Gender Ratio of PDM 2020-22

The participants completed their preparatory remedial and induction programmes and two Interactive Learning terms during the year. Only the classroom sessions of the third Interactive Learning Term could happen in the offline mode.

Development Immersion (DI): The academic calendar for the batch had to be reworked in response to the Pandemic related restrictions. The Development Immersion module has been scheduled after the third Interactive learning term.





2.2 Scholarship Support for PDM Participants

A total amount of Rs. 42,78,000/- was disbursed as scholarship to the PDM 2019-21 batch participants in their terms III and IV. Similarly, an amount of Rs. 6,75,000/- was disbursed to the participants of PDM 2020-22 for their academic performance in the Interactive Learning Term I.

3. Competencies Enhancement Programmes (CEPs)

The CEP calendar had to be significantly truncated in the wake of the OVID-19 pandemic and government restriction. There were fewer CEPs conducted in the year 2020-21 than in the previous years. During the year, phase one of three day CEPs on 'Development Leadership' planned for Block Development Officers (BDOs) of Government of Bihar (GoB), designed in consultation with the Rural Development Department, GoB, was organised from 01st to 03rd February 2021. Twenty-six officers from across the state attended the CEP. DMI conducted two Traning Needs Assessmen (TNA) workshops as per the details shown in *Table D*.

4. Collaborative Action Research and Education (CARE) Centres

4.1 Action Research on Re-imagining Basic Education

The pandemic-led closure of schools impacted the implementation of the Action Research Project on Basic Education being implemented in 13 Government schools of Bhitiharwa cluster in Gaunaha Block of West Champaran district in Bihar. Although the field team consisting of two Project Associates were stationed at Bhitiharwa from May 2020 onwards, access to key stakeholders (i.e. students, teachers, parents) could not be established, especially during the lockdown period due to restricted mobility.

Notwithstanding the challenging times, the following attempts were made as a part of the endeavour:

- During the lockdown period, securing the physical assets and facilities created under the project was necessary. The project associates worked towards this with the support of teachers and the village community.
- A survey was undertaken to understand access to remote learning platforms using mass media tools viz. TV, radio and access to electronic devices viz. smartphones, laptops etc. In a sample of 420 students, the access to these equipment and devices were abysmally low. Only 12.6% students had mobile phones with internet and 7.1% families had television sets at home. The findings clearly suggested challenges in access to educational content due to digital divide. During the unlock phase, to bridge the learning losses, the field team volunteered to conduct sessions on selected subjects for students willing to join. The handholding support was provided to small groups of students while maintaining all the safety protocols.



- A group of interested students from three middle schools were involved in mask production
 with support of two part-time sewing instructors, who are also the residents of the same
 community. 5,000 masks were prepared for the purpose of distribution among students and
 teachers of all 13 schools at the time of reopening of schools. This activity also enabled in
 extending livelihoods support to two part-time trainers.
- The project team is tracking the progress of the reopening of schools. Phase-wise reopening of schools began in the state from 04 January 2021, starting with reopening of Grades 9 and above. In the cluster, five upper primary schools reopened on 08 February 2021 and eight primary schools reopened from 01 March 2021. Initial observations suggest that the attendance in schools were low during the first week but eventually began to increase. The teachers' observations indicate that since the Mid-day Meals are not being served, students' attendance and retention in schools until the end of school hours remain a concern. DMI team plans to extend full support to teachers and students to compensate for the loss of the academic year. Along with this, the field team plans to re-launch some skill-based activities as per the approved plan, which will be initiated with the support of teachers and Head Masters. The partnerships with Pratham Education Foundation and Lend A Hand India (LAHI) will be made functional if the extension to the project is granted beyond March 2021.

4.2 Water Sanitation, and Hygiene (WASH) Observatory

The activities of the WASH Observatory (WASH-O) were not significantly affected despite the lockdown. It has worked mainly for three aspects, i.e. research, knowledge dissemination and capacity building. Under the head research, the following studies/concept notes have been conducted/developed by WASH-O in the year 2020-21:

- Tracking of IEC expenditure and processes for Lohiya Swach Bharat Abhiyan (LSBA) in Bihar,
 LSBA, GoB
- WASH Assessment of Health Care Facilities of district Patna, Bihar, for Agha Khan Foundation (AKF)
- Situational Analysis of Urban WASH in Bihar; for UNICEF
- Functionality Assessment of Piped Water Supply (PWS) Scheme; for PHED, GoB
- Scoping study of Khaira Multi-Village Surface Piped Water Scheme about the social certification process; for PHED, GoB
- Technical support to the UNICEF WASH team on data analysis of WASH indicators for 82
 health facilities in five aspirational districts of Bihar, survey checklist for village quarantine
 centre, and Community Sanitary Complex (CSC); for UNICEF
- Thematic paper on Sanitation for Bihar WASH Alliance (BIWA)



For knowledge dissemination, the WASH-O carried out the following activities:

- Creation of the WASH Observatory portal on google site for web presence and knowledge sharing, cross learnings and replications – currently featuring: WASH related news/articles, national and state Events/Days, IEC Resources, information on WASH alliance partners, programs and Projects/Research studies.
- Collaboration with the Bihar WASH Alliance partners for understanding, promoting and sharing good practices, ideas and innovations in sanitation and hygiene practices.
- Participation in the panel discussion webinar on Challenges and Opportunities in Solid Liquid Waste Management (SLWM) for Urban Local Body (ULB) members, organised by AKF on 16 June 2020.
- Creation of YouTube channel for the WASH Observatory with weekly videos on COVID-19 pandemic and WASH issues.
- Conduct of interviews with eminent persons from different government/ non-government development organisations in the monthly programme, "WASH Talks", on different WASH sector interventions and emerging WASH issues related to water supply, water quality, and sanitation hygiene promotion for a larger audience.
- Designed and floated an elective course on 'WASH Services' for DMI participants in term V.
- Initiated awareness related to hand-washing in two slums in Patna and Saran districts during Global Hand-washing Week (9th-15th October 2020).
- Organising of a webinar for DMI participants on the importance of hand-washing for improved public health outcomes, especially in the context of the present-day Covid-19 Pandemic. Besides, there was the dissemination of relevant and creative video messages on hand-washing by the Director, DMI, faculty members, participants, WASH-O team and development partners.

Under the capacity building, the activities which are completed or are planned are:

- Training Needs Assessment (TNA) carried out for LSBA State and District level officials. The programme is in the advanced stages of scheduling.
- Training Needs Assessment (TNA) for PHED Engineers. PHED has approved the training programme of Executive Engineers, Assistant Engineers and Junior Engineers based on the TNA report submitted.

In addition to the above, the WASH-O has applied with the Ministry of Drinking Water & Sanitation, GoI, for being empanelled as a Key Resource Centre (KRC) for capacity building exercises. Also, PHED has approached WASH-O to document good practices/cases of the *Har Ghar Nal Ka Jal* scheme. WASH-O intends to work closely with Jal Jeevan Hariyali Mission (JJHM) in other areas of research and capacity building. WASH-O team has discussed with the Mission Director, JJHM, to associate in research studies and capacity building initiatives. As a start, the WASH-O is developing a research proposal to understand the JJH Mission's impact on the water table. Reflecting on the upcoming training programmes and research studies, the WASH-O has developed a plan for action for the forthcoming year.

4.3 Centre of Excellence in Disaster Management (CoEDM)




The Disaster Management Department (DMD) of the Government of Bihar (GoB) had advised the Development Management Institute (DMI), Patna to submit a proposal for establishing a 'Centre of Excellence in Disaster Management (CoEDM)' at DMI. After submission of the proposal in October 2019, an MoU was signed between the DMD and DMI on the 19 May 2020. The CoEDM is proposed as an academic project unit of the Institute that will function with a dedicated human resources team and infrastructure, focused academically disaster management through training, research, education and consulting activities.

The CoEDM has commenced its work post receipt of the first instalment of sanctioned financial budget from the DMD of Rs.5 crore on the 03 August 2020.

The recruitment advertisement for hiring human resources under the CoEDM was floated in the month of September, and by December 2020, the offers were made. In February 2021, two consultants — Health Care and Medical Services and Planning and Coordination- joined the CoEDM. The Centre did a planning exercise with the involvement of representatives of UNICEF and ADPC under the chairmanship of Director, DMI on 09 February 2021 convened by Coordinator, CoEDM. To better guide and monitor the functioning of the CoEDM an Advisory Committee has been formed under the Chairmanship of Chairman, BoG, DMI.

6. Seventh DMI Foundation Day Symposium



The Seventh Foundation Day Symposium was organised on the 13-14 February, 2021 in both online (Cisco Webex platform) and offline mode at the DMI, Patna. 'Coping with the Pandemic: Experiences and Reflections' was chosen as the theme. The Symposium was inaugurated by the Chairman, DMI via virtual mode.

The Symposium deliberated on three sub-themes (Livelihoods, Education & Healthcare) spread across four technical sessions, excluding the inaugural session. Prominent among those who shared the dialogue and deliberations were Prof. Dileep Mavalankar, Director IIPH Gandhinagar; Dr. Tanmay Mahapatra, Team Lead, Concurrent Measurement and Learning Unit, Bihar Technical Support Program, CARE India; Sri Pratyaya Amrit I.A.S., Principal Secretary, Department of Health, Disaster Management Department, GoB; Sri Sanjay Kumar

I.A.S., Principal Secretary, Department of Education, GoB; Dr. Rukmini Banerjee, Chief Executive Officer of Pratham Education Foundation; Sri Rajiv Khandelwal Co-Founder and Executive Director of Aajeevika Bureau; and Dr. Chinmay Tumbe, Assistant Professor, IIM Ahmedabad. The Valedictory address was delivered by Shri Balamurugan D, CEO, BRLPS. The spirit of the discussion in all the three technical sessions of the symposium revolved around the experiences and reflections of people across the nation in coping with the Pandemic.

9. Infrastructure

9.1 Transit Campus

The Institute continues to function from its transit campus in Udyog Bhawan, Second Floor, with learning spaces and classrooms, library, seminar hall, computer centre, offices and all other facilities required as per AICTE norms for the PGDM programme. DMI thanks BIADA for allotting the spaces on a rental basis in Udyog Bhawan, Patna. In addition, DMI has also rented approx. 4,000 Sq.ft. space at ground floor of the building and developed it into the modern learning spaces, offices and a canteen for conducting competency enhancement programmes.

9.2 Knowledge Centre

During the year, additions were made to the RFID enabled state-of-the-art Knowledge Centre by way of books, journal article databases, print journals and magazines. The Knowledge Centre hosts 6,785 volumes of books comprising 6,421 titles, 2 journal article databases (EBSCO and Indiastat), 14 Indian and international journals in print format and 10,000 in electronic format, 13 magazines and 15 newspapers as on 31 March, 2021. In addition, it also houses 191 CDs and DVDs. The growth of the Knowledge Centre is a continuing process, and the resources are continuously updated.



9.3 Faculty Accommodation and Guest House

The Institute has arranged for two flats at Bailey Green Apartments, near Rupaspur Thana, Patna and five flats at Le Grassia, Nehru Nagar, North Sri Krishna Puri, Patna on lease rental basis. Five of these are used as furnished accommodation for the Director and the faculty members. Two, at Le Grassia, are used as transit guest house with a kitchen and dining facility attached to them. The dinining facility is used by interested residents on a payment basis.



9.4 PDM Participants' Hostel

The Institute has established a hostel facility with double occupancy accommodation for 120 PDM participants with good quality furniture, well-furnished discussion rooms and common rooms, a functional mess facility, internet access, etc. in 12,000 sqft of space hired in Hostel A (Ganesh Bhawan Complex) and 10,800 sqft of space hired in Hostel B (Shanti Bhawan Complex).

Both the hostel blocks are situated in the heart of the city at Kadam Kuan area in Patna, with 24 hrs security and power backup facility. All PDM participants are required to stay in the hostel, given the residential nature of PDM. Due to Covid-19 pandemic and government restrictions, PDM 2019-21 & 2020-22 batches were encouraged to attend classes through online mode in the academic year 2020.

9.5 DMI's Upcoming Permanent Campus

The Building Construction Department (BCD) of the Govt. of Bihar has undertaken the responsibility of developing the permanent campus of DMI on the request of the Rural Development Department (RDD) on the 15 Acre site at Bihta, procured from BIADA. Further, the work was awarded to Simplex Infrastructures Limited, Kolkata, through an Engineering Procurement and Construction (EPC) Contract by the Building Construction Department, Govt. of Bihar on 09 September 2019.

Shri Nitish Kumar, Hon'ble Chief Minister of Bihar laid the foundation stone for the DMI permanent campus at Bihta on 08 August 2020 via video conferencing.

10. Governance

10.1 DMI Society Meeting

The annual meeting of the Development Management Institute Society (DMI Society) could not be held for the year 2019 - 2020, due to the COVID-19 pandemic. The Audited Annual Accounts and the Annual Report of the Society were adopted through Circular Resolution dated 12th November 2020.

10.2 Extension of relieving of Prof. Hemnath Rao H. as Director, DMI

In the 21st meeting of Board of Governors (BoG), DMIS held on 22 January 2020, the resignation of the incumbent Director, Prof. Hemnath Rao Hanumankar was accepted by the BoG. He was requested to hold office till 30 June 2020 and a four-member Search Committee was constituted for selection of the new Director. The Search Committee was comprised of Shri RJM Pillai, Chairman, BoG, DMI Society (w.e.f. 15/03/2020); Prof. Shekhar Chaudhuri, Member, BoG; Prof. Anil K Gupta, Former Professor, IIM Ahmedabad (External Expert); and Ms. Sushma Iyengar, Founder, Kutch Mahila Vikas Sangathan (External Expert). Shri Anup Mukerji, Chairman, BoG had participated in the search process as Special Invitee to the meetings of the Search Committee after completion of his term as Chairman on the 15 March 2020.

Further, pending selection of a new Director, Prof. Hemnath Rao Hanumankar had been requested to continue in his current responsibility. This matter of extension of relieving of Prof. Hemnath Rao H as Director, DMI was communicated through the letter no DMI/Admin/03/14-iii/1120 dated 05 June 2020. Upon receiving approvals from seven members, the same was communicated by email dated 08 June 2020 as 'adopted'.

10.3 Appointment of Prof. Debiprasad Mishra as Director, DMI

With the approval of the Chairman, Board of Governors, the letter no DMIS/Admin/03/14/1506 dated 09 December 2020 was circulated with relevant proceedings and recommendations of the Search Committee for selection of Prof. Debiprasad Mishra as Senior Professor and Director, Development Management Institute (DMI). In response, six members of the BoG had conveyed their approval.

With the above approvals satisfying Clause 13 (sub-clause VI) of the Rules and Regulations of the DMI Society, the subject resolution was adopted.

The Board of Governors, DMI Society also appreciated and acknowledged the efforts made by the Chairman (Shri RJM Pillai), Members (Ms. Sushma Iyengar; Prof. Shekhar Chaudhuri; and Prof. Anil K Gupta) and special invitee to the Search Committee (Shri Anup Mukerji) in carrying out the Search and Selection Process, especially under the challenging circumstances caused by the Covid-19 Pandemic.

Prof. Debiprasad Mishra formally assumed the charge as Director, DMI on the 08 January, 2021.

12. Road Ahead

12.1 Academic Programmes

The Post Graduate Programme in Development Management has been the lone, long term academic offering of the Institute. As it moves to its 7th year, efforts would be made to gather the learning and reflections of these years, consolidate the programme structure and curriculum and undertake a quality journey seeking assessment and accreditation by relevant national agencies. Simultaneously, DMI will explore opportunities for other long-term academic programmes such as PDM for Working Executives and a Fellow Programme in Development Management.

12.2 Experiential Learning

As a part of the rationalisation and consolidation of the PDM (as in 12.1), the Experiential Learning component would be reviewed and re-calibrated for greater effectiveness. In particular, aspects of participants' engagements and learning outputs will be reviewed and strengthened.

12.3 CARE Centres and Research

The CARE Centres themselves and activities within their ambit require a fillip. This will be done through creative redesign of the Centres in the matrix form. DMI will explore the relevant research programmes within their thematic focus and the disciplinary/ functional orientation of the faculty members. The knowledge products of the research would be carried through a publications programme for broader dissemination.

12.4 Competency Enhancement Programmes (CEPs)

There will be efforts at expanding the variety and reach of the CEPs. Programmes that could be delivered online and offline, of varying durations, some leading to the award of Certificates, would be explored. Knowledge products that would be increasingly available from the research programme would be utilised in the CEPs.

12.5 Centre of Excellence in Disaster Management (CoEDM)

The Centre of Excellence in Disaster Management will be operationalised and developed into an inter-disciplinary and cross-functional knowledge hub. The Centre would follow up with concrete steps in pursuance of Its aspiration to be a research and competency support unit for the Department of Disaster Management.
