ELIGIBILITY CONDITIONS:

Assistant Professor – Grade II (Level 11)

For Academic Areas in Sl. 1 – 8

- A. Two-year Master's Degree in Business Administration/ PGDM/ M.Com/ MCA/ M.Tech/ CA/ ICWA/ Professional Studies, with first class or equivalent **and** PhD (or equivalent doctoral qualification) in the Academic Group applied for. Evidence of research writing in the form of review papers/ research papers/ case studies, etc., would be an advantage. **Or,**
- B. Coursework-based PhD (equivalent, i.e., Fellow Programme) in Management/ Rural Management/ Development Management or in the academic group applied for, where at least 90 credits (*one credit is ten contact hours*) were earned during coursework to qualify as a doctoral candidate. Evidence of research writing in the form of review papers/ research papers/ case studies, etc., would be an advantage.

For Academic Areas in Sl. 9-11

- A. Two years Master's Degree in Social Sciences/ Social Work/ Development Studies/ International Development/ Public Administration/ Professional Studies, with first class or equivalent, **and** PhD (or equivalent) in the Academic Group applied for. Evidence of writing in the form of review papers/ research papers/ case studies would be an advantage.

Assistant Professor – Grade I (Level 12)

Educational Qualification: Same as for Assistant Professor – Grade II

Experience: Three years of post-Doctoral academic experience (teaching or research or both)

Associate Professor (Level 13A2)

Educational Qualification: Same as for Assistant Professor Grade-II

Experience:

- A. Eight years of teaching experience at the level of Assistant Professor, of which at least five years at Level 12, **Or**,
B. Twelve years of relevant industry/ research experience, including at least three years of post-doctoral experience and five years of teaching experience at a level equivalent to an Assistant Professor at Level 12

Publications record:

Six publications – with the first authorship of at least four, including

- a. Research papers in refereed journals
- b. Cases with teaching notes in recognised case-clearing Journals/repositories
- c. Significant consulting research reports
- d. Book/ book chapter

Professor (Level 14A)

Educational Qualification: Same as for Assistant Professor Grade-II

Experience:

- A. Thirteen years of teaching experience, of which at least five years are at the level of Associate Professor, and eight years post-doctoral experience; **Or**,

- B. Seventeen years of relevant industry/ research experience, including at least eight years post-doctoral experience and five years of teaching experience at a level equivalent to Associate Professor.

Publications record:

Ten publications – with the first authorship of at least six, including

- a. Research papers in refereed journals
- b. Cases with teaching notes in recognized case-clearing Journals/repositories
- c. Significant consulting research reports
- d. Books/ book chapter

IMPORTANT INSTRUCTIONS:

1	This is an Open Rolling Advertisement . Scrutiny of applications will be done at the end of one month from the publication of the advertisement in print or on 31 st December 2025, whichever is later. This will be repeated every quarter afterwards till all requirements are fulfilled. Entries in the academic group listing will be removed as positions get filled.
2	Scrutiny and Shortlisting will be carried out by the Institute as per requirement, depending on the Academic Groups desired to be filled.
3	5% relaxation in educational qualification eligibility for SC/ST/Differently abled, and 3% for OBC and EWS candidates in Master's degree applicable.
4	Mere fulfilment of minimum eligibility criteria does not result in shortlisting.
5	The Institute may relax some requirements related to qualification, including eligibility requirements, and experience in cases of candidates with exceptional academic and domain expertise in priority areas/fields.
6	All qualifications must be from UGC-recognized Universities/ Deemed Universities or AICTE-approved autonomous institutions (wherever applicable), or foreign Universities/ Institutions of repute.
7	There will be two rounds in the selection process. The first round will be in an online mode, where the shortlisted candidates will be invited to: 1. Conduct a teaching session on a topic relevant to the field and of the applicant's interest. 2. Present a research seminar If the candidate is shortlisted in the first round, she/he, in the second round, would interact with a cross-section of faculty members and appear in an interview. The Institute's decision regarding shortlisting and selection will be final.

8	The Selection Committee may recommend candidates for appointment in positions other than the actual position applied for, including as Visiting Fellows with gross remuneration and fixed periods of contract.
9	The Institute reserves the right to fill or not to fill any or all the positions.

11	Only shortlisted candidates will be contacted. If a candidate has not been contacted, she/he should assume that her/his application has not been shortlisted.
